- Quotaholders who subscribed to the public distribution of the 4<sup>th</sup> issue of quotas ("4<sup>th</sup> Issue") of the Fund will receive a *pro rata* distribution related to the investment period that funds have been allocated in the Temporary Investments (as defined in the documents for the 4<sup>th</sup> Issue). The distribution will be for the four million, nine hundred and forty-five thousand, five hundred and fifty-three (4,945,543) quotas, as per the receipts detailed in the table below:

- The payment of the earnings will be made on May 15, 2018 via bank account deposit provided that the personal data of the respective shareholder has been fully provided. Additionally, the VISC12 and VISC13 receipts resulting from the 4<sup>th</sup> Issue of the Fund shall be converted into quotas of the Fund and they are expected to be available for trading, under the ticker/code VISC11, starting May 02, 2018.
- Quotaholders of the Fund (VISC11) on the market closing of April 30, 2018 (excluding quotas acquired in the 4<sup>th</sup> Issue) will receive earnings for April 2018, corresponding to R\$0.61 (sixty-one cents of reais) per quota, with payment date on May 15, 2018.
- The Monthly Performance Report with the detailed results for the month of April will be available by May 8, 2018.
